

TACO BELL® BETA REWARDS XBOX SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Taco Bell® Beta Rewards Xbox Sweepstakes (“Sweepstakes”) is sponsored by Taco Bell Corp., 1 Glen Bell Way, Irvine, CA 92618 and Microsoft Corporation, One Microsoft Way, Redmond, WA 98052 (“Sponsors”), is administered by Prize Logic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 (“Administrator”).

Non-winning entries will carry forward into subsequent Entry Periods, if any. The Administrator’s computer is the Sweepstakes official clock. An entry must be received before an Entry Period’s end time/date to be eligible for such Entry Period.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of one of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry and who are Taco Bell Rewards members by September 13, 2020. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address

will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant may visit RewardsXbox.com (“Website”) and complete and submit the registration form including: his/her first and complete last name (no initials), valid e-mail address, phone number, street address (no P.O. Boxes will be allowed), city, state, zip code, and/or any other request information. Upon the successful submission of the registration information, an entrant will receive one (1) entry into the corresponding Entry Period.

Entry Limit: There is a limit of one (1) total entry per person during the entire Sweepstakes Period. Non-winning entries from one Entry Period will roll into subsequent Entry Periods, if any. If more than one (1) entry is received from the same person, telephone number, and/or e-mail address the entries may, at the Sponsor’s sole discretion, be disqualified. Entrants are prohibited from using more than one (1) e-mail address or multiple identities. If it is found or suspected that an entrant is using more than one e-mail address or multiple identities to participate in the Sweepstakes, then that entrant, in Sponsor’s sole discretion, may not be eligible to win a prize.

Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. **PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**

A. Prizes (70, 10 per Entry Period): Each verified winner will receive the prize of an Xbox Series X bundle which includes: Xbox Series X console and six (6) months of Xbox Game Pass Ultimate. The ARV of each prize is \$688.99. This product and its manufacturer’s suggested retail price have not been released to market at the time of print. The ARV of Prizes is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the ARV is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed. Any difference between the approximate retail value and the actual retail value will not be awarded.

B. Total ARV: The total ARV of all prizes is \$48,229.30.

6. HOW TO CLAIM A PRIZE: The potential winners are subject to verification of eligibility and compliance with these Official Rules.
